# Affiliation process for new institute

## Definitions

National fire safety institute of research technology Government of India, Greater Noida Uttar Pradesh. During the registered in Gov. of India (Uttar Pradesh) act 1882. New institution for offering national fire safety institute of research technology approved short term diploma courses shall not be established and started without prior approval of National fire safety institute of research technology. Admission authority / Body / Institution shall not be permit admission of student to a institute offering diploma education which is not affiliation to the nfsirt. new Institution offering approval short term diploma courses and variation in take in intake capacity of existing courses shall strictly be on self-financing basic and at no stage the institute and courses shall be considered by the National Fire safety institute of research technology on grant in aids basic.

## ELIGIBILITY FOR AFFILIATION APPROVAL

It is mandatory to submit the following documents during the approval of the institution's application with the establishment of new institute for the approval of short-term diploma courses in various subjects for the National Institute of Fire Safety Research Technology.
